The Institution shall fulfill the revised Norms relating to infrastructure, instructional facilities, enhanced amount of Endowment and Reserve Fund, Number and qualifications of Teaching Staff, Curriculum and implementation strategies in view of the change in duration/intake of programme(s) offered in the institution within the time limit allowed by NCTE.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- The institution shall comply with the condition as laid down in the clause 8(3) of the NCTE Regulations, 2014 which provided that "An institution which has been recognized by the Council shall obtain accreditation from an accrediting agency approved by Council within five year of such recognition."
- The institution shall ensure that the required number of academic staff for conducting the course is always in position.
- As per the provisions of the NCTE Regulations, 2014 the following norms have been prescribed for staff qualifications/administrative and professional staff/terms and conditions of service etc.

NORMS AND STANDARDS FOR MASTER OF EDUCATION PROGRAMME LEADING TO THE MASTER OF EDUCATION (M.ED.) DEGREE - Regarding Staff

6.1 Faculty

For an intake of 50 students per unit, the faculty student ratio for a two-year programme for 100 students shall be 1:10. The faculty positions shall be distributed as under:-

1. Professors	Two
2. Associate Professors	Two
3. Assistant Professors	Six

6. The institution shall maintain & update its Web site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

7. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

9. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. ORDER

Swami Vivekanand College of Education, Vill. - Ram Nagar, Near - Banur, Tehsil - Rajpura, Patiala, Punjab - 140601 submitted an application to the Northern Regional Committee of National Council for Teacher Education for grant of recognition of B.Ed. course of one Year duration in terms of section 14(1) of NCTE Act, 1993.

2. Now, therefore, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993, the Regional Committee hereby grants recognition to Swami Vivekanand College of Education, Vill. - Ram Nagar, Near - Banur, Tehsil - Rajpura, Patiala, Punjab - 140601 for B.Ed. Course with an annual intake of 100 seats (One Hundred), w.e.f. 28th June, 2005 subject to compliance of the following conditions before commencement of the academic session.

- That the Reserve Fund for an amount equal to three months salary of the Teachers & Staff be created within one month from the date of issue of this order and maintained in the form of FDR in favour of the management/institution, for a period of not less than sixty months (Five years) in a Nationalized Bank.
- Non-compliance of the above mentioned conditions shall cause action under section 17(1) of NCTE Act, 1993.

3. The Recognition is subject to the condition that the affiliating University shall ensure that, among other things, the institution has appointed required number of faculty members (including Principal / Head of Department), as per the norms of the NCTE / UGC / Affiliating University.
